National Defense Authorization Act (NDAA) and the Trade Agreements Act (TAA)

Background / Content of the NDAA (Previously H.R.5515) Section 889

Cybersecurity Concerns Impact U.S. Government Agencies and U.S Military Video Surveillance Deployments.

The John S. McCain National Defense Authorization Act for Fiscal Year 2019 (US Government appropriations and procurement) was sighed into U.S. Law. To authorize appropriations for fiscal year 2019 for military activities of the Department of Defense, for military construction, and for defense activities of Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes. Aug 13, 02018.

The Act includes video surveillance equipment under the "covered telecommunications equipment" definition and calls out specific vendors, cameras, and components which are expressly forbidden for use in US Government-related video surveillance deployments. LILIN does not employ any certain components or critical technology from several outlined Chinese manufacturers.

Content of the TAA Conformity Statement

The Trade Agreements Act("TAA") was enacted on July 26,1979 which promotes fair and open international trade. It requires the U.S. government and entities with federal contracts to purchase final products from sources that are manufactured in the United States and from countries recognized as supporting fair and open international trade, or come from other TAA designated countries. The bill further requires contractors to prove that their end products purchased by the U.S. government must actually meet the above manufacturing location requirements and those items, materials and supplies purchased for public use.
